This enables me to answer your questions and requests. These data will be stored on a security server owned by <https://wendyvanmieghem.com> or by a third party. I will not combine your personal data with other data.

### Cookies

I collect data for research to get a better insight in our clients in order to tailor our services/products.

This website uses cookies. A cookie is a small piece of data sent from a website and stored in a user's web browser while the user is browsing the website. Every time the user loads the website, the browser sends the cookie back to the server to notify the website of the user's previous activity.
